



## *Wild Adventures “Find our Hearts Scavenger Hunt”*

### **2017 Official Rules**

**Eligibility:** NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Sweepstakes is offered only in the fifty (50) United States (and the District of Columbia). Void where prohibited by law. All individuals who are legal U.S. residents and 18 years of age or older and of the age of majority in their jurisdiction of residence at time of entry are eligible to enter (*excluding residents of the States of Arizona, New York, and Rhode Island*). Employees of Sponsor and their respective parents, subsidiaries, affiliates, representatives, suppliers, vendors, and advertising and promotion agencies and their immediate families (parent, child, spouse, sibling and their respective spouses, regardless of where they reside) and those living in the same household of each, whether or not related, are not eligible to enter or to win the Sweepstakes.

**Timing:** Sweepstakes begins at 12:00 AM Eastern Daylight Savings Time (“EDT”) March 11, 2017 and ends at 11:59 PM Eastern Standard Time (“EST”) on December 31, 2017 (the “Sweepstakes Period”).

**How To Enter:** There are two (2) forms of entry during the Sweepstakes Period: (1) register by completing an entry form at any of the 5 merchandise locations within Wild Adventures’ Theme Park (the “Park”) and successfully completing *Wild Adventures “Find Our Hearts Scavenger Hunt”* (as detailed below); or (2) mail in your entry by submitting your first and last name, street address, city, state, zip, daytime and evening telephone numbers (area code included), email address (optional), and date of birth on a plain 3” x 5” piece of paper and mail in a properly stamped #10 business-sized envelope to: *Wild Adventures “Find our Hearts Scavenger Hunt”* c/o Wild Adventures Theme Park, 3766 Old Clyattville Road, Valdosta, Georgia 31601. All mail-in entries must be received by 11:59 PM EDT/EST the day prior to each Monthly Drawing Date (as further described below) to be eligible for drawing. Limit one (1) Sweepstakes entry per person, per household, per day, per card, per envelope. Photocopied, computer generated facsimiles, mechanically re-produced, automated, mass entries and entries by any means which subvert the entry process will be void. **How To Play:** Participants will pick up an entry form at any of the 5 merchandise locations within the Park. Using the icon or images as clues on the back of the card, you will travel throughout the Park to find the specified number of 18” hearts located on your card (the number of hearts may differ during each Monthly Entry Period as defined below). Each heart will contain a corresponding icon or image like shown on the card. Write down the location of each heart next to the icon/image. After you have found all the hearts and noted the locations on your scavenger hunt/entry card, drop off the completed card at the box located inside Adventure Emporium. You must complete all of the information on the card – first name, last name, telephone number, email

address, etc. – and correctly identify the locations of the hearts - in order for the entry to be valid for a chance to win the monthly prize(s) and/or Grand Prize.

**Sweepstakes Drawings and Odds of Winning:** Sweepstakes winners will be selected for the prize(s) from entries received during the Sweepstakes Period in random drawings (as detailed below) conducted by Sponsor whose decision is final and binding in all matters relating to the Sweepstakes. Odds of winning are determined by the total number of entries received. In the event a potential winner is at least 18 years of age but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian who will be responsible for fulfilling all requirements imposed on winner set forth herein.
